TEARMS AND CONDITIONS FOR NEW PEARL FARMING SETUP

- 1) Food and lodging cost of pearl farming setup team will be beard by the client whose setup will be done. Fooding includes proper breakfast, lunch and dinner which should be provided on timely basis.**
- 2) 50% Payment of the total company cost will be paid by client after site visiting or before project starts and remaining 50% payment once our team reaches at clients place. The work will only be initiated once the remaining 50% payment is made by the client.**
- 3) Client have to pay the 1st site visiting charges which later will be deducted from 1st 50% payment .**
- 4) After making the final 50% payment of company cost if the client chooses not to do the setup or ask to reduce the quantity then that payment is 30% refundable.**
- 5) From the very first day of the surgery some local labours will be provided by the client as helping hand and for netting of the mussels. Number of labours will be depend upon mussels quantity .Client will be informed about the labours requirement a week prior.**
- 6) When the mussels are getting deployed in the pond after 24 hours of surgery, its clients responsibility to check on how many mussels are getting deployed in the pond on everyday basis till the completion of the project .**
- 7) On the netting day If client fails to provide labour for netting and due to late deploy if mortality happens then the client can not ask for extra mussels or blame the company. In such scenario no refunds will be made to client by the company.**

8) All tools and materials which is required for the completion of the project will be decided by the company and not by the client. If client wants to do any additional activities 1st He/She have to take permission from company.

9) Transportation cost till the nearest railway station wherever unloading is possible will be beard by the company. Transportation, loading and unloading charges from railway station to clients site will be beard by the client . Client can not ask for any particular railway station as unloading of mussels is not possible on every railway station.

10) This buyback agreement will only be considered legitimate once the client has made the entire payment to the company for their services. If the client fails to make the full payment after availing the services then this agreement will be considered null and void.

11) Following things are not allowed in the project :-

- A) Mussels from outside
- B) Surgeries by outsiders
- C) Surgery tools from outside
- D) Net bags for mussels from outside
- E) Nucleus from outside

12) Company is responsible for the mortality of the mussels till the time they are deployed in the pond. After that it's client responsibility to take care of the project and health of the mussels. Company can't be held responsible for the mortality of mussels after the completion of the project.

13) From site preparation till harvesting client have to work as per company's guidance .

14) Mussels feeding charges will be beard by client on monthly basis .

15) Client have to follow all terms & conditions if He/She dosen't then the agreement will be UNACCEPTABLE .
